Resonant Raman spectroscopy of twisted multilayer graphene

Graphene and other two-dimensional crystals can be combined to form various hybrids and heterostructures, creating materials on demand with properties determined by the interlayer interaction. This is the case even for a single material, where multilayer stacks with different relative orientation have different optical and electronic properties. Probing and understanding the interface coupling is thus of primary importance for fundamental science and applications. Here we study twisted multilayer graphene flakes with multi-wavelength Raman spectroscopy. We find a significant intensity enhancement of the interlayer coupling modes (C peaks) due to resonance with new optically allowed electronic transitions, determined by the relative orientation of the layers. The interlayer coupling results in a Davydov splitting of the C peak in systems consisting of two equivalent graphene multilayers. This allows us to directly quantify the interlayer interaction, which is much smaller compared with Bernal-stacked interfaces. This paves the way to the use of Raman spectroscopy to uncover the interface coupling of two-dimensional hybrids and heterostructures.

Bulk graphite consists of individual graphene planes stacked in a hexagonal (Bernal)¹ structure, or, less commonly, in a rhombohedral² one. Single (SLG) or multi-layers (MLG) of graphene can be extracted from graphite by micro-mechanical cleavage³. MLGs produced by micro-mechanical cleavage retain the stacking structure of the bulk⁴. The optical and electronic properties of hexagonal or rhombohedral MLGs have significant differences, as shown, for example, in ref. 5 for Bernal and rhombohedral trilayer graphene (TLG). Furthermore, for a given stacking, the band structure significantly changes as a function of the number of layers, N (ref. 6). An even wider range of properties is accessible by creating MLG with stacking arrangements different from those common in natural graphite. We refer to these as twisted MLG (tMLG), to indicate a mutual orientation of the planes different from the naturally occurring one. In twisted BLGs, novel physical properties arise because of the periodically modulated interaction between the two Dirac electron gases with a large moiré supercell⁷. These have a Dirac-like linear dispersion with Fermi velocity lower than in SLG^{7–9}. By changing the twist angle (θ_t), it is possible to tune the optical absorption¹⁰. Twisted BLGs have parallel electronic bands across the Fermi level and the energy of the corresponding van Hove singularities (VHSs) depends on θ_t (ref. 11). By assembling m -layer (mLG, $m \geq 1$) and n -layer (nLG, $n \geq 1$) flakes, a $(m+n)$ -system is formed, which we indicate as $t(m+n)$ LG. In this notation, a Bernal-stacked BLG is denoted as 2LG, whereas a twisted one as $t(1+1)$ LG. A flake consisting of a Bernal-stacked BLG placed at a generic angle θ_t on a Bernal-stacked TLG is indicated as $t(2+3)$ LG. This has significantly different properties when compared with a Bernal-stacked 5LG, or to a $t(1+4)$ LG, or $t(1+1+3)$ LG and so on, even though all these have the same $N=5$. For a given total N , the choice of m , n and so on (with $m+n+\dots=N$) and relative angles between each m , n ,...LGs leads to a family of systems with different optical and electronic properties^{12,13}. The ability to probe the interlayer coupling between the interface layers of mLG and nLG in $t(m+n)$ LGs, and its impact on the electronic band structure and lattice dynamics, is crucial to reach a fundamental understanding of these systems and to tune them for novel applications.

Raman spectroscopy is one of the most used characterization techniques in carbon science and technology^{14,15}. The Raman spectrum of graphite and MLG consists of two fundamentally different sets of peaks. Those, such as D, G and 2D, present also in SLG, and due to in-plane vibrations^{14,16,17}, and others, such as the shear (C) modes¹⁸ and the layer breathing modes^{19–21}, due to the relative motions of the planes themselves, either perpendicular or parallel to their normal. The G peak corresponds to the high-frequency E_{2g} phonon at Γ . The D peak is due to the breathing modes of six-atom rings and requires a defect for its activation^{16,22–24}. It comes from TO phonons around the Brillouin Zone (BZ) edge $K^{16,22}$, is active by double resonance (DR)²⁴, and is strongly dispersive with excitation energy due to a Kohn Anomaly (KA) at K^{43} . DR can also happen as intra-valley process, i.e. connecting two points belonging to the same cone around K or K' . This gives the so-called D' peak. The 2D peak is the D peak overtone. The $2D'$ peak is the D' overtone. Since 2D and $2D'$ originate from a process where momentum conservation is satisfied by two phonons with opposite wavevectors, no defects are required for their activation, and are thus always present⁴. In graphite and BLG, there is only one low-frequency E_{2g} mode, called C, as it is sensitive to the interlayer coupling¹⁸. In a MLG comprising N layers, there are $N-1$ C modes, which we indicate as C_{NN-i} with $i=1,\dots,N-1$. In this notation, for a given N , the label C_{N1} is used for the highest frequency C peak, which is the only C mode thus far observed in Bernal-stacked MLG¹⁸. Thus, a TLG has two C modes, C_{32} and

C_{31} , the latter being the highest frequency one. Some of these are Raman active, others are infrared active and others are both, according to symmetry and N (ref. 18). The C peak position, Pos(C), is below the notch and edge filter cut of many spectrometers, particularly those suitable for production-line quality monitoring. This problem was overcome by combining BraggGrate filters with a single monochromator¹⁸. This allowed us to measure the highest energy C modes for Bernal-stacked MLGs¹⁸. However, their intensity, $I(C)$, is much smaller than that of the G peak, $I(G)$, because of the much lower electron-phonon-coupling (EPC)¹⁸, and it is smaller the lower the Pos(C), for a given N . Thus, so far, the lower energy C modes for a given N could not be detected¹⁸. Similar C modes exist in any other layered material^{18,25}, but their intensity is comparable to that of the main high-frequency Raman peaks, allowing for the detection of some of the possible $N-1$ C modes for a given N ^{25,26}, not just the highest energy one. Note that, albeit being an overtone of an in-plane mode, the 2D peak is sensitive to N since the resonant Raman mechanism that gives rise to it is closely linked to the details of the band structure^{4,15,17}, the latter changing with N , and the layers relative orientation¹⁵. On the other hand, the C modes are a direct probe of N (ref. 18), since the vibrations themselves involve the relative motion of different graphene planes, and not just the relative motion of carbon atoms in a given plane of graphene.

Here we study the C modes of $t(m+n)$ LGs. We find that their intensities are enhanced in an excitation energy range depending on m , n and θ_t . For a given $N=m+n$, this allows us to detect $m+n-2$ C modes arising from the $m-1$ and $n-1$ expected for the constituent mLG and nLG in the $t(m+n)$ LG stack. By analysing their Pos(C), we find that the coupling between the graphene layers at the twisted interface can be significantly weaker than that in Bernal-stacked FLGs. The coupling to the layers adjacent to the interface is also softened. In the case of a $t(2+2)$ LG, the out-of-phase and in-phase vibrations of the two twisted, equivalent BLGs, result in a Davydov splitting of $\sim 2\text{ cm}^{-1}$ for the C peaks of the two constituent BLG peaks. The Raman intensity of the C and G modes is significantly enhanced in $t(m+n)$ LGs for specific excitation energies. This behaviour is assigned to the resonance between VHSs in the joint density of states (JDOSs) of all optically allowed transitions in twisted multilayer samples and the laser excitation energy, during the optical absorption and emission steps of the Raman process. The VHSs contribute to different extent to the resonant profiles, which is a sign of varying EPC for different C bands.

Results

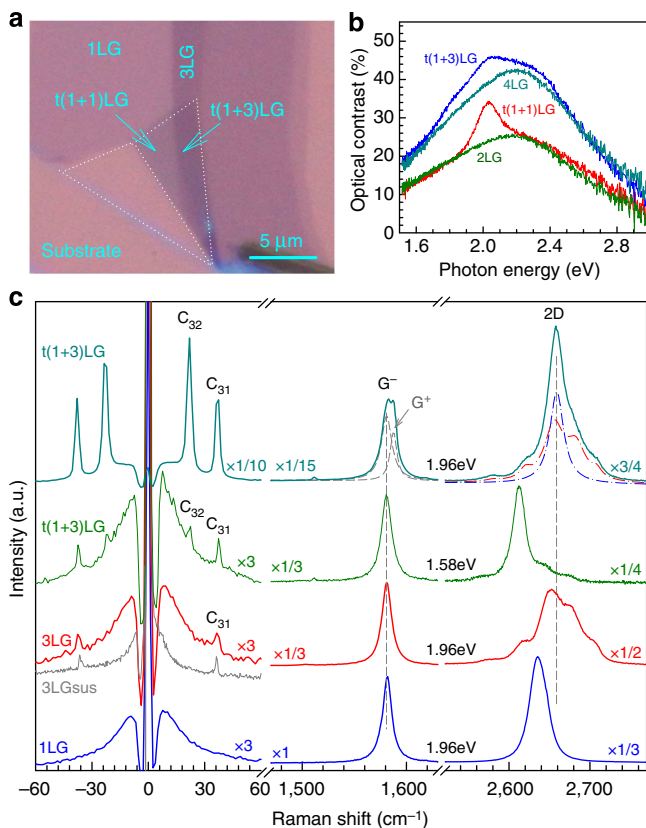


Figure 1 | Optical characterization and Raman spectra of $t(1+3)$ LG.

Raman spectroscopy of $t(n+m)$ LG. We consider a flake comprising SLG, TLG, $t(1+1)$ LG and $t(1+3)$ LG regions, the latter formed by folding SLG onto TLG/SLG during mechanical exfoliation of graphite (see Fig. 1a; see Methods for details). The optical contrasts of $t(1+1)$ LG and $t(1+3)$ LG in Fig. 1b are, respectively, different from those of 2LG and 4LG. We note that an additional feature appears at $\sim 2\text{ eV}$ for both $t(1+1)$ LG and $t(1+3)$ LG, a fingerprint of the different band structure in twisted samples, when compared with Bernal-stacked ones^{27,28}.

Figure 1c plots the Raman spectra, measured as described in Methods, in the spectral ranges of the C, G and 2D bands, for an excitation energy $E_{\text{ex}}=1.96\text{ eV}$. The spectra are normalized to $I(G)$ of the SLG sample. The 2D band of $t(1+3)$ LG can be fitted using the peak profiles of the SLG and TLG 2D bands, as indicated by the dashed-dotted lines in Fig. 1c. The fitted SLG-like and TLG-like sub-peaks for $t(1+3)$ LG are blue-shifted by ~ 24 and 5 cm^{-1} , respectively, relative to those found in pristine SLG and TLG. Note that the full width at half maximum of the G

peak, FWHM(G), and Pos(G) of $t(1+3)$ LG measured for 1.58 eV excitation are identical to those of 3LG and 1LG, as indicated in Fig. 1c. Thus, we assume that doping or strain are not responsible for the blue-shift of the 2D bands in $t(1+3)$ LG. The blueshift can be attributed to the decrease of Fermi velocity in $t(1+3)$ LG, similar to what previously reported for $t(1+1)$ LG in refs 7,9,29. This is another indication that the constituent SLG and TLG couple with each other in the $t(1+3)$ LG sample, producing a unique band structure, different from that of the individual constituents and from that expected for 4LG. $I(G)$ of $t(1+3)$ LG is also 15 times stronger than that of SLG. As the Raman intensity scales with volume, one would expect $I(G)$ for a sample with 4 layers of graphene to be 4 times bigger than that of a SLG, instead of the 15 times measured here. This suggests a resonant enhancement of $I(G)$ at 1.96 eV. A similar enhancement was previously observed in $t(1+1)$ LG^{27,29}, where the measured $I(G)$ was 20–60 times bigger than in SLG for a specific excitation energy, instead of the expected factor 2. We also note that FWHM(G) of our $t(1+3)$ LG is $\sim 18 \text{ cm}^{-1}$, broader than the $\sim 12 \text{ cm}^{-1}$ intrinsic in pristine SLG^{30,31}. Closer inspection shows that the G band consists of two sub-bands, which we call G^- and G^+ , using a similar terminology to that used in strained graphene³². However, the G peak of $t(1+3)$ LG measured at

1.58 eV has a single Lorentzian lineshape, with identical width and position to the G^- peak of $t(1+3)$ LG measured at 1.9 eV. This implies that the doubling of the G peak is connected to a resonant process.

Figure 1c also shows that the C mode of the SiO_2 -supported 3LG is observed at $\sim 37 \text{ cm}^{-1}$, with a worse signal-to-noise ratio than that of the suspended 3LG (3LG_{sus}), because of the strong background from the Si substrate¹⁸. The $t(1+3)$ LG sample consists of 4 graphene layers. In Bernal-stacked 4LG, $4-1=3$ C modes are expected at ~ 41 (Raman active), 31 (infrared active) and 17 cm^{-1} (Raman active)¹⁸, but only one of them at $\sim 41 \text{ cm}^{-1}$ was previously measured¹⁸. In a TLG, $3-1=2$ C modes are expected at ~ 38 (Raman and infrared active) and 23 cm^{-1} (Raman active)¹⁸, but only one of them at $\sim 38 \text{ cm}^{-1}$ was previously measured¹⁸. In our $t(1+3)$ LG, we detect two C peaks at ~ 22 and $\sim 37 \text{ cm}^{-1}$, as confirmed by the presence of their anti-Stokes components. Their positions are in excellent agreement with those expected for the two Raman active modes in TLG, and not with those expected in a 4LG. We thus ascribe them to the C_{32} and C_{31} of the 3LG constituent in $t(1+3)$ LG, since, of course, SLG cannot have any C mode. We also note that $I(C_{32}) \sim I(C_{31}) \sim I(G)$ in the $t(1+3)$ LG, whereas $I(C_{31})/I(G) \sim 0.02$ in TLG, thus the C modes in $t(1+3)$ LG are enhanced a factor ~ 50 . This is another indication that the coupling between the SLG and TLG constituents of the twisted sample results in a heterostructure with properties, such as the band structure, distinct from those of its constituents.

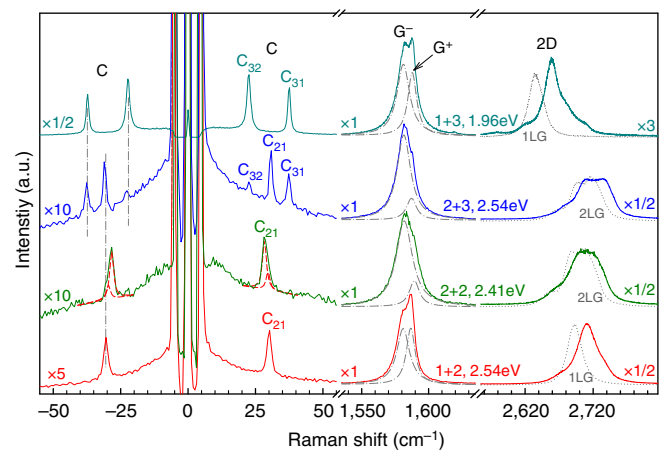


Figure 2 | Raman spectroscopy of $t(m+n)$ LG. Stokes/anti-Stokes Raman spectra in the C peak region and Stokes spectra in the G and 2D spectral regions for four $t(m+n)$ LGs. For comparison, the 2D peaks in SLG and Bernal-stacked BLG are plotted using dotted lines. The fits show that the G band of each $t(m+n)$ LG is composed of two subpeaks, G^- and G^+ . The excitation energy used for each $t(m+n)$ LG is indicated. The spectra are scaled and offset for clarity. The scaling factors of the individual spectra are also shown.

Similar results are found for other $t(m+n)$ LGs (see Supplementary Fig. 1 for optical images). Figure 2 shows the Stokes (S) and anti-Stokes (AS) spectra in the C spectral region and Stokes spectra in the G and 2D spectral regions for four $t(m+n)$ LGs with $m=1$ or 2 and $n=2$ or 3. To facilitate comparison, all spectra are normalized to their respective $I(G)$. The 2D bands of all $t(m+n)$ LGs are blue-shifted relative to those measured under the same conditions for SLG, BLG, TLG, as also seen in Fig. 1. In the $t(1+2)$ LG sample, we detect only one C mode located at $\sim 30 \text{ cm}^{-1}$, close to $\text{Pos}(C_{\text{BLG}}) = 32 \text{ cm}^{-1}$ measured for Bernal-stacked BLG¹⁸. $t(2+2)$ LG exhibits a broad and asymmetrical peak with $\text{FWHM} = 2.2 \text{ cm}^{-1}$, once the

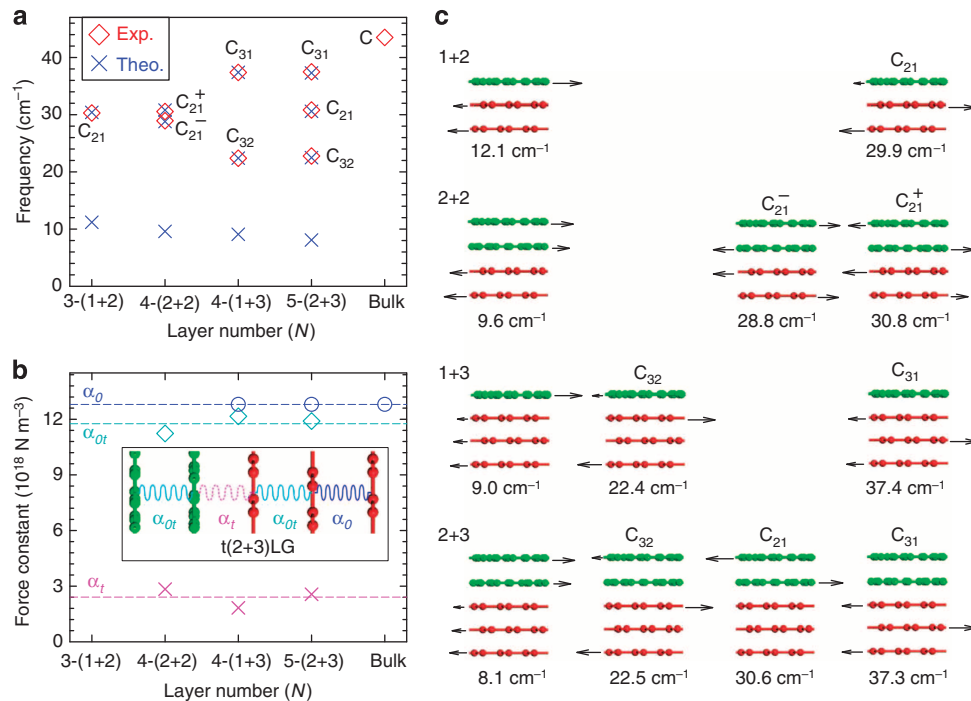


Figure 3 | Shear mode frequencies and normal mode displacements in $t(m+n)$ LG. (a) Experimental (Exp., open diamonds) and theoretical (Theo., crosses) $\text{Pos}(C_{NN-i})$ in $t(m+n)$ LGs ($N=m+n$). (b) Fitted shear force constants (α_t and α_{0t}) in $t(m+n)$ LGs. The inset shows a schematic diagram of a linear chain model for $t(2+3)$ LG including a bulk interlayer force constant, α_0 , interface force constant, α_t and the softened force constant for the layers adjacent to the interface, α_{0t} . (c) Normal mode displacements and mode frequencies from the linear chain model in **b**.

system resolution ($\sim 0.5 \text{ cm}^{-1}$) is accounted for. This is 1.2 cm^{-1} bigger than that ($\sim 1 \text{ cm}^{-1}$) measured in Bernal-stacked BLG. In fact, this band can be fitted using two Lorentzians at $\sim 28.9 \text{ cm}^{-1}$ and 30.6 cm^{-1} , denoted as C_{21}^- and C_{21}^+ , respectively. In $t(2+3)$ LG, besides the two C modes of its 3LG constituent, an additional mode at 30.8 cm^{-1} related to its 2LG constituent is present, with a small FWHM $\sim 1 \text{ cm}^{-1}$. In $t(1+3)$ LG, as shown in Fig. 1 and discussed above, two C modes related to its 3LG constituent are observed. In short, $m+n-2$ C modes are observed in a $t(m+n)$ LG for specific excitation energies, instead of $m+n-1$ C modes expected in Bernal-stacked $(m+n)$ LGs. The observed modes are related to the C modes of the constituent m LG (if $m > 1$) and n LG ($n > 1$). The frequencies of all C modes shown in Fig. 2 are summarized in Fig. 3a using open diamonds.

Similar to $t(1+3)$ LG, a G^- and G^+ double peak structure is observed in the G peak region for all $t(m+n)$ LGs, as revealed by the Lorentzian fits shown in Fig. 2. Also, for each $t(m+n)$ LG, the G^+ mode can only be observed in a small E_{ex} range (see the Supplementary Fig. 2), whereas the G^- component always exists. The G^+ peak is observed neither in Bernal-stacked SLG, TLG, 4LG nor in $t(1+1)$ LG. The observed G^+ position in $t(m+n)$ LGs is $6-7 \text{ cm}^{-1}$ higher than the G peak in a Bernal-stacked $N(=m+n)$ LG, whereas the G^- component is at $\sim 1,581 \text{ cm}^{-1}$, independent on E_{ex} . We note that the split between the Raman-active E_{2g} and infrared-active E_{1u} modes in bulk graphite is $\sim 6 \text{ cm}^{-1}$ (ref. 33). Therefore, one might attribute the G^+ peak in $t(m+n)$ LGs to the E_{1u} -like zone-centre mode of their 2LG and 3LG constituents.

Interlayer coupling at the twisted interface. To understand the interlayer coupling in $t(m+n)$ LG, we use the linear chain model introduced in ref. 18. However, in the case of twisted samples, we

need to consider that the interlayer coupling between the constituent Bernal-stacked sub-layers may not be the same as that inside each Bernal-stacked layer and that the presence of the interface perturbs the force constant between the two layers closest to the interface in both sub-layers. We denote the interlayer shear force constant between two sub-layers (m LG and n LG) by α_t and the perturbed force constant adjacent to the interface in m LG and/or n LG by α_{0t} . The force constant per unit area between bulk layers away from the interface is given by α_0 . In FLGs, this interlayer force constant was experimentally determined to be $\alpha_0 = 12.8 \times 10^{18} \text{ Nm}^{-3}$ (ref. 18). The force constants are illustrated in the inset of Fig. 3b for a $t(2+3)$ LG case. The frequencies ω (in cm^{-1}) and displacement patterns of the shear modes in $t(m+n)$ LG can be calculated by solving linear homogeneous equations follows³⁴:

$$\omega_i^2 \mathbf{u}_i = \frac{1}{2\pi^2 c^2 \mu} \mathbf{D} \mathbf{u}_i, \quad (1)$$

where \mathbf{u}_i is the phonon eigenvector of the mode i with frequency ω_i , $\mu = 7.6 \times 10^{-27} \text{ kg } \text{\AA}^{-2}$ the monolayer mass per unit area, $c = 3.0 \times 10^{10} \text{ cm s}^{-1}$ the speed of light and \mathbf{D} the shear part of the force constant matrix (for details, see Supplementary Note 1).

Based on the experimental C mode frequencies of $t(2+2)$ LG, $t(1+3)$ LG and $t(2+3)$ LG, we can fit the parameters α_{0t} and α_t . The average values for α_{0t} and α_t are $11.8 \times 10^{18} \text{ Nm}^{-3}$ and $2.4 \times 10^{18} \text{ Nm}^{-3}$, respectively. These values suggest that the interlayer coupling at the interface between the twisted Bernal layers is ~ 5 times weaker than the coupling in the Bernal-stacked layers, whereas the coupling between layers next to the interface, α_{0t} , decreases by $\sim 9\%$ with respect to α_0 .

The theoretical and experimental $\text{Pos}(C_{NN-i})$ in $t(m+n)$ LGs are summarized in Fig. 3a as crosses and open diamonds, respectively. Figure 3c shows the normal mode displacements calculated using equation (1). The mode displacements are

mainly localized within the n LG or m LG constituents and they are only weakly affected by the coupling across the twisted interface. We also note that a low-frequency mode below 15 cm^{-1} is theoretically predicted. This corresponds to the relative vibration of the m LG and n LG constituents in $t(m+n)$ LGs, as illustrated in Fig. 3c. However, we have not been able to detect this in our experiments to date, possibly due to a very weak EPC.

Davydov splitting of the C mode. In Fig. 2, two subpeaks, split by $\sim 2\text{ cm}^{-1}$, are found for the $t(2+2)$ LG C peak. It is interesting to compare the lattice dynamics of $t(2+2)$ LG and Bernal-stacked 4LG. The C_{41} mode of 4LG at 41 cm^{-1} does not exist in $t(2+2)$ LG because of the weak coupling at the interface. The C_{42} mode at $\sim 31\text{ cm}^{-1}$ of 4LG is infrared-active¹⁸. As shown in Fig. 3b in ref. 18, for this mode the two middle layers move in phase, and the two BLGs are out-of-phase with respect to each other. Thus, the mode displacement is similar to that in two uncoupled BLGs. Thus, $\text{Pos}(C_{42}) \sim 31\text{ cm}^{-1}$ is equal to that of the C mode in 2LG (the latter, however, corresponding to a Raman active mode)¹⁸. In $t(2+2)$ LG, the displacements of the middle layers are in-phase for C_{21}^- . Its lower frequency (28.8 cm^{-1}) than that of the BLG C_{21} and 4LG C_{42} suggests a softening of the coupling between layers next to the interface. C_{21}^+ has a higher frequency than C_{21}^- because the weakly coupled middle layers vibrate out-of-phase in this case. If this coupling were as strong as in the Bernal-stacked case, $\text{Pos}(C_{21}^+)$ would be much higher than $\text{Pos}(C_{21}^-)$, close to $\text{Pos}(C_{41})$ in 4LG. The frequency difference between C_{21}^- and C_{21}^+ is referred to as Davydov splitting³⁵, which is the frequency difference of two conjugate vibration modes. Such splitting is a direct signature of the presence of coupling, albeit weak, between the two interface layers. The weak interlayer coupling at the interface between the

constituent BLGs is also confirmed by analysing the positions of the three C modes in $t(2+2)$ LG. The frequency of the relative vibration between the two constituent BLGs in $t(2+2)$ LG can be approximately deduced³⁶ as $\sqrt{\omega_{C_{21}^+}^2 - \omega_{C_{21}^-}^2} = 10.9\text{ cm}^{-1}$, which agrees well with the calculated 9.6 cm^{-1} . A similar C mode Davydov splitting is expected to occur in all $t(n+n)$ LGs.

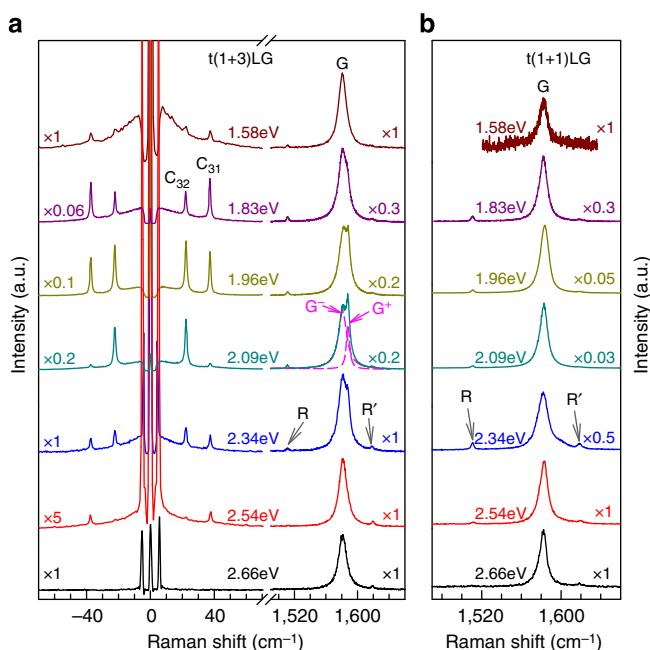


Figure 4 | Raman spectra of $t(1+3)$ LG and $t(1+1)$ LG at different excitation energies. (a) C and G modes of $t(1+3)$ LG and (b) G mode of $t(1+1)$ LG for seven E_{ex} . The R and R' modes are indicated by arrows. The presence of the G^+ mode is revealed by the two-Lorentzian fit to the $t(1+3)$ LG G band measured at 2.09 eV. The spectra are scaled and offset for clarity. The scaling factors of the individual spectra are also shown.

Raman intensity. The C and G^+ modes for each $t(m+n)$ LG can only be detected in a small E_{ex} range, suggesting a resonant mechanism. Here we consider in detail the case of $t(1+3)$ LG and a reference $t(1+1)$ LG, where no C nor G^+ peaks are expected. Figure 4 plots the measured spectra at seven wavelengths both for $t(1+1)$ LG and $t(1+3)$ LG, with peak intensities normalized to I(G) in a SLG. I(G) in $t(1+1)$ LG and I(C), I(G^-) and I(G^+) in $t(1+3)$ LG strongly depend on E_{ex} . Figure 4a shows that the G^+ peak in $t(1+3)$ LG can only be observed in a small E_{ex} range.

In order to explain the origin of the resonant enhancement, we calculate the band structure corresponding to our $t(1+1)$ LG and $t(1+3)$ LG samples. θ_t determines the coupling between the constituent n LG and m LG and needs to be known to perform meaningful calculations. θ_t can also be expressed in terms of the twist vector^{7,37} (p, q). The so-called R and R' Raman bands have been suggested as probes of θ_t in $t(1+1)$ LG^{38,39}. As shown in Fig. 1a, in our experiment the same SLG is folded onto both SLG and TLG regions to form the $t(1+1)$ LG and $t(1+3)$ LG samples. Consequently, as the top and bottom layers in our $t(1+1)$ LG and $t(1+3)$ LG are the same SLG, both systems have the same θ_t . The R and R' peaks of our $t(1+1)$ LG are measured to be $\sim 1,510$ and $1,618\text{ cm}^{-1}$, whereas in the $t(1+3)$ LG, they are at $\sim 1,512$ and $1,618\text{ cm}^{-1}$. From the position of the R band, θ_t can be determined as $\sim 10.6^\circ$ for both $t(1+1)$ LG and $t(1+3)$ LG, following the procedure used in ref. 39 for a $t(1+1)$ LG sample. This is close to a twist vector of (1,9) and $\theta_t = 10.4^\circ$. The optical contrast of $t(1+1)$ LG in Fig. 1b shows an absorption peak at $\sim 2.03\text{ eV}$, which agrees with that calculated in ref. 39 for (1,9) $t(1+1)$ LG. We thus use a twist vector of (1,9) and $\theta_t = 10.4^\circ$ in our band structure calculations for $t(1+1)$ LG and $t(1+3)$ LG.

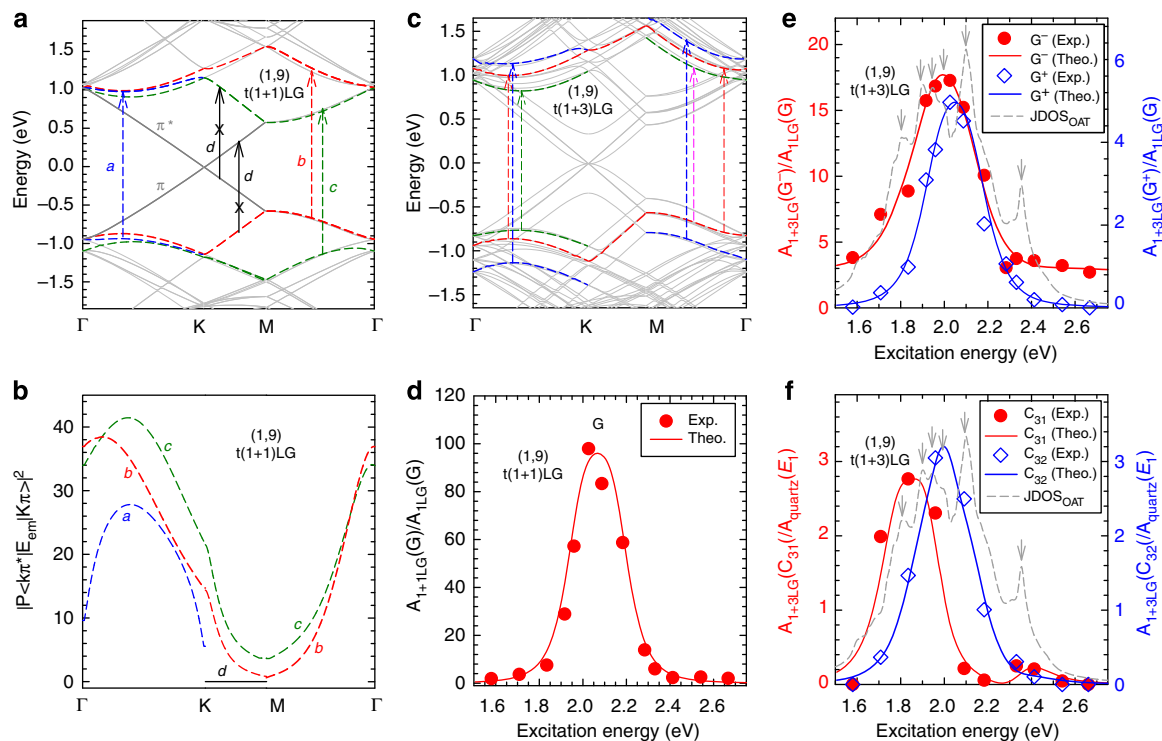


Figure 5 | Intensity resonance of the C and G modes. (a) Band structure of (1,9) $t(1+1)$ LG. The optically allowed transitions are marked by dashed arrows. The transitions with energy ~ 1.15 eV between parallel bands along \mathbf{K} - \mathbf{M} are forbidden, as indicated by solid arrows with crosses. (b) Squared optical matrix elements of the corresponding band pairs in a. (c) Band structure of (1,9) $t(1+3)$ LG. Some typical transitions are indicated by vertical dashed lines. (d) $A(G)$ of $t(1+1)$ LG, (e) $A(G^-)$ and $A(G^+)$ of $t(1+3)$ LG, and (f) $A(C_{31})$ and $A(C_{32})$ as a function of laser excitation energy. The filled circles and open diamonds are the experimental data, while the solid lines show the simulations. The grey dash-dotted lines in e and f are the electronic joint density of states (JDOSs) of all the optically allowed transitions (JDOS_{OAT}) in $t(1+3)$ LG along Γ -K-M- Γ . The VHSs of JDOS_{OAT} are indicated with arrows.

We calculate the band structure of (1,9) $t(1+1)$ LG with the Density Functional based Tight Binding (DFTB+) code, as discussed in Methods⁴⁰, in Fig. 5a. Figure 5b plots the squared optical matrix elements for pairs of electronic transitions between conduction and valence bands in Fig. 5a. The electronic transitions are optically allowed if the corresponding squared optical matrix element is non-zero. For example, the optical transitions of (1,9) $t(1+1)$ LG between two parallel conduction and valence bands along the K-M direction, labelled by the two arrows with crosses in Fig. 5a, are optically forbidden because of their zero squared optical matrix element, as indicated by curve d in Fig. 5b, as the corresponding Raman matrix element expressed within the third-order perturbation theory is quenched. The optically allowed transitions in (1,9) $t(1+1)$ LG are indicated by dashed lines with arrows. The optical matrix elements are anisotropic along the high-symmetry directions, as for Fig. 5b.

The band structure of (1,9) $t(1+3)$ LG is shown in Fig. 5c. In the low-energy region, two parabolic bands from the 3LG can still be seen. A linear band arising from the SLG constituent is superimposed with that of the TLG constituent to form a doubly degenerate linear band, with a Fermi velocity $\sim 4\%$ smaller than in SLG, because of the coupling at the interface. This reduction manifests itself in a blueshift of the SLG-like 2D peak in Fig. 1c. The selection rule for optically allowed transitions in $t(1+3)$ LG is more complex than in $t(1+1)$ LG. As an example, some optically allowed transitions in $t(1+3)$ LG are shown in Fig. 5c with vertical arrows. This results in a broader absorption peak in $t(1+3)$ LG in comparison to $t(1+1)$ LG, as shown in Fig. 1b.

The experimental areas of the G band in $t(1+1)$ LG [$A(G)$] and the G and C bands in $t(1+3)$ LG [$A(G^-)$, $A(G^+)$, $A(C_{31})$ and $A(C_{32})$] as a function of E_{ex} are plotted in Fig. 5d–f. The G modes are normalized to $A(G)$ of SLG, whereas the C modes are normalized to the quartz substrate E_1 modes (at 127 cm^{-1})⁴¹ to eliminate the effect of different charge-coupled device (CCD) efficiencies at each E_{ex} . The Raman intensity of the C and G modes is then calculated by second-order perturbation theory⁴². Because only the optically allowed electronic transitions can be involved in the resonant Raman process²⁷, we calculate the electronic JDOSs of all the optically allowed transitions (JDOS_{OAT}) in $t(m+n)$ LG by the following equation:

$$\text{JDOS}_{\text{OAT}}(E) \propto \sum_{ij} \sum_{\mathbf{k}} |M_{ij}(\mathbf{k})|^2 \delta(E_{ij}(\mathbf{k}) - E), \quad (2)$$

where $M_{ij}(\mathbf{k})$ is the optical matrix element between the i^{th} conduction and j^{th} valence bands, $E_{ij}(\mathbf{k})$ gives the transition energy of a $i \rightarrow j$ band pair at the wavevector \mathbf{k} , 180 \mathbf{k} -points are used for the summation along the Γ -K-M- Γ path, distributed according to the respective path lengths in the reciprocal space. The optically allowed transitions in $t(1+1)$ LG shown in Fig. 5a contribute to a VHS at 1.95 eV with FWHM = 0.13 eV (see Supplementary Fig. 3). The JDOS_{OAT} for $t(1+3)$ LG is shown in Fig. 5e,f by grey dashed lines. There are six distinctive VHSs in the JDOS_{OAT} of (1,9) $t(1+3)$ LG, which are labelled by arrows (see the Supplementary Fig. 4). $t(1+3)$ LG has broader JDOS_{OAT} (FWHM = 0.5 eV) than $t(1+1)$ LG, because of its more complex band structure. The major contribution to the intensity comes from resonance matching between E_{ex} and

the VHSs energies of the JDOS_{OAT}. Therefore, the intensity of Raman modes in $t(m+n)$ LG as a function of E_{ex} can be evaluated as³⁹:

$$A \propto \left| \sum_j \frac{M_j}{(E_{\text{ex}} - E_{\text{VHS}}(j) - i\gamma)(E_{\text{ex}} - E_{\text{ph}} - E_{\text{VHS}}(j) - i\gamma)} \right|^2, \quad (3)$$

where M_j are constants treated as fitting parameters that encompass the product of the electron–phonon and electron–photon interactions matrix elements for the j^{th} VHS in the JDOS_{OAT}, E_{ph} is the phonon energy (0.196 eV for G, 0.197 eV for G^+ , 4.6 meV for C_{31} , 2.7 meV for C_{32}) and γ gives the energy uncertainty related to the lifetime of the excited state. Here we assume $\gamma = 0.15$ eV. The calculated $A(C)$ and $A(G)$ as a function of E_{ex} are shown in Fig. 5d–f with solid curves. Both are in good agreement with experiments.

The resonant profile of the G^+ peak for $t(1+3)$ LG is symmetric and centred at 2.05 eV with a width of 0.3 eV, which indicates that the VHSs of JDOS_{OAT} with lower (<1.8 eV) and higher (>2.3 eV) energies contribute little to it. However, that of the G^- peak is asymmetric and slightly broader, implying that the corresponding VHSs with a wider energy range contribute to its resonance, particularly in the lower energy range (<1.9 eV). When out of resonance, the G^+ peak vanishes, whereas $I(G^-)$ of $t(1+3)$ LG is about three times that of $I(G)$ in SLG.

Because of the small energy of the C phonon, the resonance condition for both incoming and outgoing photons can be simultaneously nearly fulfilled. This significantly enhances $A(C_{NN-i})$ when in resonance with the optically allowed transitions in $t(1+3)$ LG, as demonstrated in Fig. 5c,f. Indeed,

$A(C_{31})$ and $A(C_{32})$ excited at 1.96 eV are ~ 120 and 190 times that of $A(C_{31})$ in Bernal-stacked 3LG, and are comparable to $A(G^-)$ and $A(G^+)$. In particular, both C_{31} and C_{32} exhibit broad resonant profiles with a width comparable to that of the G^- and G^+ peaks. The resonant profile of C_{32} is blue-shifted by 0.13 eV relative to that of C_{31} . $A(C_{32})$ is resonantly enhanced by the transitions associated with VHSs at 2.1 eV, which contribute little to $A(C_{31})$, whereas $A(C_{31})$ is significantly enhanced by the transitions associated with VHSs below 1.8 eV. Note that there is a weak resonant peak at 2.4 eV for $A(C_{31})$, which corresponds to the VHSs at 2.36 eV.

For an electronic transition at some wavevector \mathbf{k} , the matrix elements related with electron–photon interactions are the same for C_{31} and C_{32} . The EPC matrix element, however, can be different. Indeed, the EPC strength greatly varies for the different graphene phonon branches^{31,42,43}. As the EPC of C_{41} in 4LG is ~ 15 times larger than the other Raman-active C_{43} mode at 17 cm^{-1} , the other C modes are challenging to detect¹⁸. The observation of different resonant profiles for C_{31} and C_{32} indicates that, in addition to differences in the EPC strength, the EPC is also anisotropic in the \mathbf{k} space, thus removing the contribution from some optically allowed transitions to the resonant Raman process of some vibration modes. This results in the significant difference between the resonant profiles of C_{31} and C_{32} , although their phonon energy is smaller than 5 meV. This also explains the different resonant behaviour of G^- and G^+ .

Discussion

The C mode of Bernal-stacked FLG can be fitted with a Breit-Wagner-Fano (BWF) line shape¹⁸. This is attributed to quantum interference between the C mode and a continuum of electronic transitions near \mathbf{K} (ref. 18). Our calculation of the $t(1+3)$ LG band structure reveals that twisting cannot induce a band gap near \mathbf{K} . Therefore, a similar BWF profile can be present for the C mode in the twisted system, similar to that in Bernal-stacked 3LG. However, the intensity enhancement of the C mode in $t(1+3)$ LG masks the weak BWF profile, giving an overall Lorentzian profile.

The weak coupling between the two interface layers in $t(m+n)$ LGs can be understood considering the nature of C modes, that originate from interlayer shear vibrations. Because of the twist, the atoms at the interface are misaligned with respect to each other, which results in a weaker moiré-modulated coupling between the two interface layers, compared with the ordered arrangement in conventional AA-, AB- or ABC-stacked FLG.

Because the C peak positions directly reflect the interlayer interactions, the measurement of the C modes in $t(m+n)$ LG allows the direct evaluation of interlayer interactions, both at the twisted interface and in the neighbouring layers. The coupling across this interface is weaker than the interaction between Bernal-stacked layers. Nevertheless, such a weak interaction can modify the electronic dispersion, as proven by the resonant enhancement of the C modes. This paves the way to the use of Raman spectroscopy to uncover the interface coupling of two-dimensional hybrids and heterostructures.

Methods

Sample preparation. Highly oriented pyrolytic graphite is mechanically exfoliated on a Si substrate covered with a 90-nm SiO_2 to obtain multilayer graphene⁴⁴. To form $t(m+n)$ LG, a m LG flake is folded onto a n LG during the exfoliation process, or a m LG flake from one Si substrate is transferred onto a n LG on another Si substrate. The number of layers in all initial and twisted flakes is identified by Raman spectroscopy and optical contrast^{4,45,46}.

Raman measurements. Raman spectra are measured in back-scattering at room temperature with a Jobin-Yvon HR800 Raman system, equipped with a liquid-nitrogen-cooled CCD, a $\times 100$ objective lens (numerical aperture = 0.90) and several gratings. The excitation energies are 1.58 and 1.71 eV from a Ti:Sapphire laser, 1.96, 2.03, 2.09 and 2.28 eV from a He-Ne laser, 1.83, 1.92, 2.18, 2.34 and 2.41 eV from a Kr^+ laser, and 2.54, 2.67 eV from an Ar^+ laser. The resolution of the Raman system at 2.41 eV is 0.54 cm^{-1} per CCD pixel. Plasma lines are removed from the laser signals, using BraggGrate Bandpass filters. Measurements down to 5 cm^{-1} for each excitation are enabled by three BraggGrate notch filters with optical density 3 and with FWHM = $5\text{--}10 \text{ cm}^{-1}$ (ref. 18). Both BraggGrate bandpass and notch filters are produced by OptiGrate Corp. The typical laser power is $\sim 0.5 \text{ mW}$, to avoid sample heating.

Calculations. Band structure calculations are carried out using DFTB in its DFTB+ implementation^{40,47,48}. This code is based on a second-order expansion of the Kohn–Sham total energy in Density-Functional Theory^{49,50} with respect to charge density fluctuations. The Coulomb interaction between partial atomic charges is determined using the self-consistent charge formalism⁵¹. A Slater Kirkwood-type dispersion⁵² is employed for the van der Waals and π - π stacking interactions. Here we adopt the parameter set ‘mio-0-1’⁵¹ for Slater–Koster files. This approach was shown to give reasonably good prediction of the band structure in graphene and related systems^{53,54}.

To calculate the optical matrix elements, the tight-binding model of refs 7,55 is used. The model hopping parameters are scaled by 18% (refs 27,29,56) to compensate for the underestimation of Fermi velocity in the absence of corrections because of electron–electron interactions⁵⁷.

The optical matrix elements are calculated as⁴²:

$$\langle \mathbf{k}\pi_i^{*0} | E_{e-m}^{\text{in[out]}} | \mathbf{k}\pi_j^{*0} \rangle = \mathbf{P}_{\text{in[out]}} \cdot \langle \mathbf{k}\pi_i^{*0} | \nabla H_{\mathbf{k}} | \mathbf{k}\pi_j^{*0} \rangle, \quad (4)$$

where π_i^{*0} denotes the i th state in the valence (conduction) band and $\mathbf{P}_{\text{in[out]}}$ is the light polarization. Unpolarized light is considered by summing incoherently over x and y polarizations.
